The Executive Officer reported that the Commission's next meeting will be on July 28 when Commissioners will likely hear a failed psychological evaluation appeal and may also hear a failed drug test appeal. Commissioners will also officer elections for the 2023/24 fiscal year.

She said there were no new appeals filed this week. Currently, there are five release from probation; three failed psychological evaluation; one allocation appeal; and one failed drug appeal pending before the Commission.

Executive Officer Dowdin Calvillo provided the following end of the fiscal year stats:

- ➤ The Commission conducted six meetings (averaging one meeting a month)
- ➤ The Commission considered 10 separate class studies adopting recommendations from nine of the 10 studies, denying its first set of recommendations in more than 10 years. Of the nine class studies, the Commission supported:
 - establishing 17 new classes
 - o revising 12 existing classes
 - o holding one class
- > The Commission managed a total of 65 appeals:
 - 22 exam disqualification appeals (none pending)
 - 20 failed drug test appeals (one pending)
 - o 17 release from probation (five still pending)
 - three Failed Psychological Evaluation appeals (all pending)
 - one Allocation appeal (placed in abeyance by the union on behalf of the Appellant)
 - o one Exam Evaluation appeal (none pending)
- One Commissioner retired, one Commissioner tragically passed away, and two new Commissioners were appointed.

Seeing no further business before the Commission, and without objection, Chair Bloise adjourned the meeting without objections at 2pm.
